# PROFESSIONAL ACRYLIC SEALANT FOR PAINTERS

## DESCRIPTION

Sikacryl®-150 is a 1-component, non-sag, fast drying acrylic dispersion sealant for painters.

## USES

Sikacryl<sup>®</sup>-150 is designed for sealing of indoor connection joints with low movement in substrates such as concrete, aerated concrete, plaster, fibre cement, brick, plasterboards, aluminium, PVC and wood. Sikacryl<sup>®</sup>-150 is designed for indoor connection joints around windows, window sills, doors, PVC pipes, dry participation walls and ceiling.

Sikacryl<sup>®</sup>-150 is also designed for interior crack filling (for cracks not under permanent water immersion).

## **APPLICATION INSTRUCTIONS**

For the application of Sikacryl<sup>®</sup>-150 all standard construction guidelines apply.

#### SUBSTRATE PREPARATION

The substrate must be clean, dry, sound and homogeneous, free from oils, grease, dust and loose or friable particles. Sikacryl®-150 adheres without primers and/or activators.

For porous substrates, e.g. concrete, plaster and/or wood, Sikacryl®-150 can be dissolved in water (1:1 to 1:5 ratio) and be used as a primer if necessary. On plastics and paints, adhesion tests must be performed prior to application. Iron and steel must be protected with an anti-corrosion primer.

#### **APPLICATION METHOD / TOOLS**

Sikacryl<sup>®</sup>-150 is supplied ready to use.

After the necessary substrate preparation, insert a cartridge into the sealant gun and extrude Sikacryl®-150 into the joint making sure that it comes into full contact with the sides of the joint and avoids any air entrapment. Sikacryl®-150 sealant must be firmly tooled against the joint sides to ensure adequate adhesion.

It is recommended to use masking tape where exact joint lines or neat lines are required. Remove the tape within the skin time. Do not use tooling products containing solvents. Water can be used if wet-tooling is required.

#### **CLEANING OF EQUIPMENT**

Clean all tools and application equipment immediately after use with water. Once cured, residual material can only be removed mechanically.

## IMPORTANT CONSIDERATIONS

- Sikacryl®-150 can be overpainted. However, paints must first be tested to ensure compatibility by carrying out preliminary trials (e.g. according to ISO technical paper: Paintability and paint compatibility of Sealants).
- Colour variations may occur due to exposure to chemicals, high temperatures and/or UV-radiation (especially with the colour white). However, a change in colour is purely of aesthetic nature and does not adversely influence the technical performance or durability of the product.
- Application during high temperature changes is not recommended (movements during the curing).
- Do not use Sikacryl<sup>®</sup>-150 as glass sealer, in floor joints, in sanitary joints, on marble, natural stones, and civil engineering.
- Do not use Sikacryl®-150 for joints under water pressure or for permanent water immersion.
- Do not use Sikacryl<sup>®</sup>-150 on bituminous substrates, natural rubber, EPDM rubber or on any building ma-

terials which might bleed oils, plasticizers or solvents that could attack the sealant.
